



Frequently Asked Questions

Broad Creek Cub Adventure (Resident) Camp

Q. How much does camp cost?

Cub Adventure Weekdays and Weekends

3-day, 2-night program

Programmed for Cubs entering 2nd, 3rd, 4th and 5th grades in the Fall after camp, but open to all Cub Scouts and siblings of Cub Scouts.

\$215 per youth (\$195 if registered by June 1st)
\$185 per additional Cub Scout sibling
\$70 per adult
\$70 per sibling younger than Cub-age

Weeklong Adventure

6-day, 5-night program

Programmed for Cubs entering 4th or 5th grades in the Fall after camp, but open to all Cub Scouts and Cub-aged siblings with camping experience. Not appropriate for siblings younger than Cub age.

\$325 per youth (\$300 if registered by June 1st)
\$265 per additional Cub Scout sibling
\$100 per adult

Q. Does a parent have to come with their Cub?

All overnight Cub Scout camping is designed for Cubs to attend with their families. This is where they will feel safest and will have the most positive outdoor experience. While in some cases it's not required, we ask that you find the time to attend with them if you can.

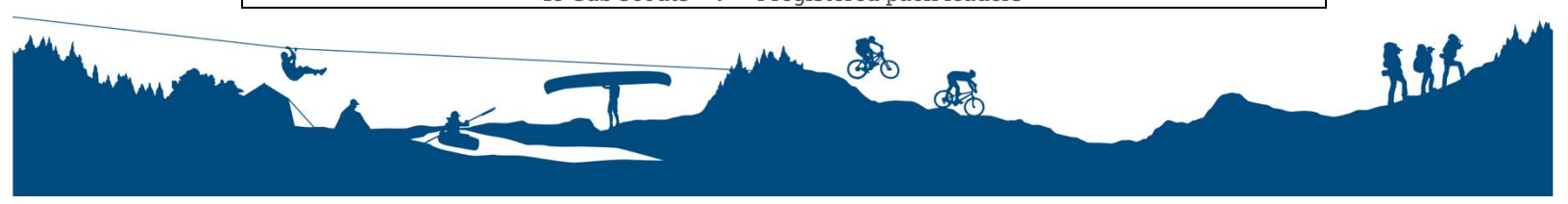
All Tiger and Lion Cubs, as well as any siblings not registered as Cub Scouts, must have a parent present to participate.

All other ranks of Cub Scouts may attend without parents if they attend with their Cub Scout Pack. Packs attending camp need at minimum two registered adult leaders aged 21+.

Cubs attending Cub Adventure Weekend (3-day) may attend with their family or as part of a Cub Scout Pack. Cubs attending the Weeklong Adventure (6-day) must attend with their pack and have a ratio of two adults to a maximum of eight youth and one additional adult for each four additional youth (or part thereof). All adults participating in the Weeklong Adventure (6-day) must be registered members of the BSA, including parents.

The following are all acceptable examples for minimum adult supervision:

6-day	3 Cub Scouts and 2 siblings	: 2 registered pack leaders (one is parent of siblings)
	7 Cub Scouts	: 2 registered pack leaders
	9 Cub Scouts	: 3 registered pack leaders
	13 Cub Scouts	: 4 registered pack leaders

Q. Can Packs split between the 3-day and 6-day share leadership?

Yes, if appropriate adult supervision is met during the remainder of the 6-day program.

Q. What is the timeline for registration and payments?

For all sessions, a \$50 per-person deposit is required to reserve your spot. Full payment is due two weeks in advance of your session. To take advantage of the early-bird discount, the \$50 deposit must be paid by June 1st.

Q. What activities are provided?

Cub Adventure Camp will provide the following activities, depending on your Cub's rank:

 - Knot-tying
 - Animal encounters

 - Team-building games
 - Climbing (Webelos and AOLs only)
- STEM
 - Game design
 - Rockets!
 - Crafting

Q. What should I bring?

- Sleeping bag
- Pillow
- Cub Scout activity shirts, at least 2 or more depending on the number of days you are camping
- Cub Scout uniform for dinner
- Regular clothes – enough to cover your stay in camp
- Underwear for every day
- Socks for every day
- Swimsuit
- Towel & washcloth
- Toothpaste & toothbrush
- Bath soap
- Shower shoes if possible
- Tennis shoes and/or boots – no open toed or slip on shoes
- Sunscreen
- Bug spray
- Money for the Trading Post if allowed

Q. Where is Broad Creek?

Broad Creek is located in northern Harford County in Whiteford Maryland approximately one hour north of Baltimore City. The camp address is Broad Creek Memorial Scout Reservation, 1929 Susquehanna Hall Road, Whiteford, MD 21160.

Q. Why do all adults attending the 6-day session need to register with the BSA, even if they aren't Pack leaders?

The Boy Scouts of America requires any adult who will be camping more than 72 hours to be a registered member of the Boy Scouts of America. They must also complete the Youth Protection Training course found at my.scouting.org.

Q. So does that mean each adult must pay the \$45 to register with the BSA?

Yes. The national fee to register as an adult with the BSA is \$45.00. The Baltimore Area Council also requires a \$4.00 insurance fee. The total cost to be an adult member of the Baltimore Area Council, BSA is \$49.00.

Q. What facilities are available at camp?

- Canvas tents with cots
- Flush toilets
- Water at campsite
- Electricity at campsite
- Free WiFi at RHQ
- Basketball court
- Volleyball court
- Gaga pit
- Archery range
- Rifle range
- Shotgun range
- Cabins
- Trading Post

Q. Some of my Scouts cannot afford to go to camp. Is there financial assistance available?

Yes. Camperships are available for Scouts in need. The campership deadline is March 31, 2023.

Q. What is expected of parents and adults at camp?

Parents and adults are expected to help provide supervision to their children and help them with activities as needed.

Q. I went to summer camp in 2022, is my medical form still good for 2023?

Medical forms are good for one year from the date of the last physical examination as long as there are no significant health changes.

For example: if the physical was done in June 2022, and summer camp is August of 2023, this physical would not be good for summer camp.

If the physical was done in September 2022, yes it would be good for summer camp in August 2023 as long as there are no significant health changes.

Q. If I completed a physical in April for sports do I need to get a new physical done for summer camp?

No. Just have the doctor sign the BSA medical form and/or attach the physical report to the BSA medical form.

Q. Can I bring my own tent?

Yes. You can bring your own tent to camp. We provide canvas-covered platform tents with cots. These tents do not zipper close and are open at the bottom.

Q. Can I bring a bike to camp?

Yes. You must also wear a helmet when riding your bike in camp. Bikes are to be ridden on paved roads when at all possible. Elbow and knee pads are recommended but not required.

Q. Can I share a campsite with my friends?

Yes. We camp campers together from the same unit in the same campsite.

Q. Can I bring snacks to camp?

Yes. It is recommended any snacks brought to camp be in sealed containers small enough to fit under the cot. About the size of a medium sized storage bin.
